

**ORDINANCE 09-4**

**AN ORDINANCE ESTABLISHING USER RATES FOR  
RESIDENTIAL AND COMMERCIAL CUSTOMERS.**

**BE IT ORDAINED** by the Mayor and Council of the City of Cochran, Georgia, and it is hereby ordained by authority thereof that the following User Rates shall be charged to its customers.

**WATER RATES**

Residential and Commercial

Inside City ..... First 1000 gallons \$10.00 (minimum)  
All over 1000 \$ 2.00

Outside City ..... First 1000 gallons \$20.00 (minimum)  
All over 1000 \$ 3.15

**SEWER RATES**

Residential

Inside City ..... First 1000 gallons \$8.00 (minimum)  
All over 1000 \$2.50

Residential

Outside City ..... First 1000 gallons \$12.00 (minimum)  
All over 1000 \$3.50

Commercial

Inside City ..... First 1000 gallons \$15.00 (minimum)  
All over 1000 \$2.75

Commercial

Outside City ..... First 1000 gallons \$22.50 (minimum)  
All over 1000 \$4.00

**\*\*\* Maximum Sewage Charge For Residential \$60.00 per month \*\*\***

**GARBAGE**

Residential ..... \$20.00 per month  
Commercial ..... \$4.50 per cubic yard

**GAS**

Inside City ..... \$7.50 minimum  
Per mcf \$3.30 plus cost

Outside City ..... \$7.50 minimum  
Per mcf \$3.30 plus cost

**DEPOSIT RATES**

Gas	\$ 150.00	
Water	\$ 50.00	
Connection Fee	\$ 35.00	Normal Business Hours
	\$ 50.00	After Normal Business Hours
Reconnection Fee	\$ 50.00	Normal Business Hours
	\$ 75.00	After Normal Business Hours
Rereads	\$ 25.00	No charge if read incorrectly

If bill is not paid by the due date, service will be subject to disconnection. Accounts 60 days past due will be disconnected and a reconnection fee will be charged for restoring service.

The above residential and commercial User Rates are to be effective upon date of adoption of said ordinance.

All ordinances and parts of ordinances in conflict herewith are hereby repealed.

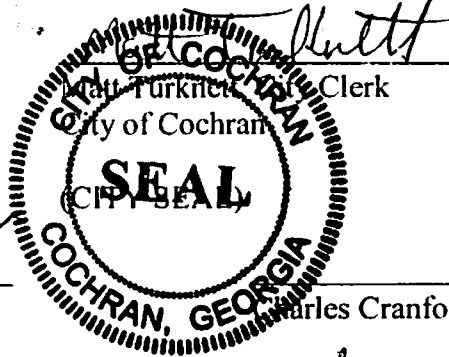
