Call to order by Mayor Pro Tem Andrew Lemmon

The invocation was given by Mayor Pro Tem Andrew Lemmon followed by the Pledge of Allegiance led by Councilmember Jon Thrower. made a motion and seconded the motion to approve the Agenda. Motion passed unanimously with all voting in favor. 5-0

Mayor Pro Tem Andrew Lemmon asked for a motion to approve the minutes from August 8, 2017 meeting. Councilmember Jon Thrower made a motion to approve September 26, 2017 minutes and mayor Councilmember Charles Cranford seconded the motion. Motion was passed with all voting in favor. 5-0

VI. Agenda Items

ITEM# 1 - Presented by City Manager, Richard Newbern

Proclamation/ Plaque for Fire Lieutenant Jacob (JJ) Speer's years of service to the City of Cochran. Proclamation. Richard read the proclamation in honor of Lieutenant JJ Speer and Fire Chief Kevin Noles presented Mr. Speer with a plaque for his years of service with The City of Cochran. Councilmember Thrower made the motion to adopt the proclamation to honor JJ Speer with Councilmember Anderson seconded the motion. Motion passed with all voting in favor. 5-0.

ITEM #2 - Presented by City Manager, Richard Newbern

Consider approving Allied Corrosion Industries Inc. in the amount of \$18,820 to perform a replacement ground bed on 11th Street. The issue was discussed about having several bidders for the project. Jacob Daniels and Skip Layton explained this company has always completed this work and were specialist is this kind of work. Councilmember Thrower made the motion to a proceed with the replacement of the grounded and Councilmember Anderson seconded the motion. Motion passed with all voting in favor. 5-0

ITEM #3- Presented by City Manager, Richard Newbern

Consider maintenance options for the City's right-of-way's and ditches. Mr. Newbern explained about the memo with the different options in the pre meeting packets. The cost of the options presented were discussed. Councilmember Gilman made the motion to table this item with Councilmember Cranford seconded the motion. Motion passed with all voting in favor 5-0.

ITEM # 4 - Presented by City Manager, Richard Newbern

Consider traffic safety options on Oak Street near Peach and Peter Street intersections. Mr. Newbern asked Police Chief Chris Coley to present this item. He stated a 4-way stop would be placed at the Palm and Oak. Councilmember Cranford was concerned about the traffic speeding through this area. Mr. Coley stated if the stop sign didn't seem to work, then other options such as speed bumps would be placed in the road to deter speeders. Councilmember Cranford made the motion to place the 4 way stop at Palm and Oak with Councilmember Gilman seconding. Motion passed with all voting in favor 5-0.

ITEM #5 - Presented by City Manager, Richard Newbern

Consider approving a purchase from PACE Analytical Services (\$3,518) for a series of four (4) wet tests at the wastewater treatment plant. Mr. Newbern explained the benefits of conducting the wet test and it is mandatory by the EPD. Councilmember Gilman asked how many bids were received. Jacob Daniels elaborated this was another specialty project and it was always completed by PACE. Councilmember Gilman was concerned about not having 3 bids as Charter states. Jacob stated in order to keep our permit, this test had to be

done by a specialist. Councilmember Gilman made the motion to have the wet test done with Councilmember Thrower seconding. Motion was passed with all voting in favor. 5-0.

ITEM #6 - Presented by City Manager, Richard Newbern

Consider approving a payment of \$9,056 to Bleckley County for the City's portion of the Cochran – Bleckley Joint Comprehensive Plan. Mr. Newbern asked Council to approve the payment to Bleckley Co. Bleckley Co has already paid for this and needs to be reimbursed. Council Adopted the plan and Councilmember Gilman made the motion to make the payment. Councilmember Cranford seconded the motion. Motion passed with all voting in favor. 5-0

ITEM #7 - Presented by City Manager, Richard Newbern

Consider approving purchase and style of Custom Cochran Logo Street Pole Banner. Pictures of banner choices were given to each Councilmember. They were asked to choose from one. They chose the Green banner. Councilmember Gilman made the motion to approved the green banner and to make the purchase of banners.

ITEM #8 - Presented by City Manager, Richard Newbern

Consider contracting with JEC Electrical Contractors in the amount of \$5,000. Police Chief Chris Coley gave a background on the generator and explained the benefits of having the generator connected to the Police Department. He also told Council he tried to get bids several times before for this project and no one would place a bid. He then talked with Eric Jerrell who will do the job for \$5,000.00. Councilmember Thrower made the motion to approve contracting with JEC Electrical to complete project with Councilmember Cranford seconded. Motion was passed with all voting in favor 5-0.

Public Comments (Please note that every individual who signs up to speak prior to the meeting will be given a total of five minutes to address the Mayor and Council.)

- Catherin Guyton- Mrs. Guyton stood before the Council and expressed how upset she was about the stealing at the Recreation Department. Mrs. Guyton went on to explained about how much the grass was out of control on 9th Street and Peacock. Councilmember Thrower stated the owner has recently been sick and he would go over and cut the grass at the location in discussion. Speeders were another issue Mrs. Guyton brought to the attention of the Council. Police Chief Coley stated he would have officers monitoring the area.
- Diane Lester Mrs. Lester asked if Earnest Lawson- Walker road was in the city or county? Public Works Director Jacob Daniels stated it was in the county. She also is concerned about the roads not being paved and wanted to know if there was a list or way to keep up with the roads being paved. Councilmember Thrower responded that a list was provided to Council tonight.
- Sam Barrs Mr. Barrs presented to the Council a project that he feels would be a great asset to Cochran. He presented a flag pole with the American flag and a triangle name plate made of wood attached to the front. This would be for anyone in Cochran who would like the plague to be in honor of an individual in the military or in memory. There will be a charge for this project and the city would have to store the flag poles. He suggested the flags could be placed on Dykes Street. His goal is to have them displayed twice a year- July 4th and, 7 days before and 7 days after, and

November 11, 7 days before and 7 days after. Mr. Barrs and Mr. Newbern will work together to make this project a success. Mr. Brrs asked for the Councilmembers to approve this project rolling. Councilmember Thrower made the motion to approve this project with Councilmember Anderson seconding the motion. Motion passed with all voting in favor 5-0.
