Call to order by Mayor Billy Yeomans @ 7:00PM

The invocation was given by Councilmember Keith Anderson followed by the Pledge of Allegiance led by Councilmember Jon Thrower.

Councilmember Andrew Lemmon made the motion and Councilmember Keith Anderson seconded the motion to approve the Agenda for Tuesday, April 10, 2018. Motion passed unanimously with all voting in favor.

Mayor Billy Yeomans asked if any corrections or additions needed to be made to the minutes for April 10,2018. No corrections or additions were added. VI. Agenda Items

ITEM# 1 – Presented by City Manager, Richard Newbern

Public Hearing on Close- out of 2014 Sewer Improvement CDBG.

Public Hearing was called to order at 7:03PM by Mayor Yeomans. Mayor Yeomans read about the work that has been completed during this project. He asked for and public input, No one from the public spoke.

Public Hearing was closed @ 7:06pm.

ITEM #2 – Presented by City Manager, Richard Newbern

Proclamation for Municipal Clerks Week. Mayor Yeomans read the proclamation and presented the signed copy to City Clerk, Tracy Jones. He thanked her for all the hard work she provides to the city.

ITEM # 3- Presented by City Manager, Richard Newbern

Consider award bid to Dykes Grassing for LMIG- funded resurfacing project A total of \$84,348 will be financed form the Georgia DOT LMIG Program and 9,372 will be Road SPOLST funds. Dykes Grassing was the only sealed bid received for this project. Bids were opened Tuesday, April 24, 2018. Dykes Grassing will apply 12.5mm of asphalt. Public Works Dept. will assist with raising sewer manhole where needed. Councilmember Jon Thrower made the motion to consider the award bid to Dykes Grassing with Councilmember Andrew Lemmon seconding the motion. Motion passed with all voting in favor.

ITEM # 4 - Presented by City Manager, Richard Newbern

Consider Adopting a resolution amending Code of Ordinances Chapter-4 Alcoholic Beverage and General Provision Section 1-15(c). This ordinance will provide for graduated penalties for establishment that are repeat offenders to underage alcohol sale regulations. Presently the max cap for the penalties is \$1,000. The following is a suggested amendment,

- ▶ 1st Offense: \$1,500 with 12 months' probation
- 2nd Offense: \$2,500, 18 months' probation, 2day license suspension (within 2 years of most current previous offense)
- 3rd Offense and Subsequent: \$3,000, 24 months' probation, and 5-day License Suspension (within 2 years of most current previous offense)

ITEM # 5 - Presented by City Manager, Richard Newbern

Consider Resolution to contact with Penn Credit to provide collection services for delinquent Police and Municipal Court Fines. This collection service sponsored through Georgia Municipal Association (GMA). This collection service will help the City collect delinquent fine payments owed to the City. Councilmember Jon Thrower made the motion to approve Penn Credit with Councilmember Gooch seconding the motion. Motion passed with all voting in favor 5-0

ITEM # 6- Presented by City Manager, Richard Newbern

Consider award of bids for purchase and installation of a replacement aeration blower for the wastewater treatment plant, to be paid from Sewer SPLOST. The aeration blower will be mounted on the existing frame in the blower house. The blowers are used to generate aeration and churn water in the digester and equalization basin. The City solicited three bids from license electric companies that either supply or perform work at municipal waste water treatment facilities. Councilmember Jon Thrower made the motion to approve Cook Electric to win the bid for aeration blower and Councilmember Regina Gooch seconded the motion. Motion passed with all voting in favor. 5-0

ITEM # 7- Presented by City Manager, Richard Newbern

Consider award of bid on repair of four sinkholes at wastewater treatment plant. Since the waster treatment plant site was built in 2001, four air holes have developed over time due to underground leaks in the lower lines. Bids from sewer contractors will be opened on Monday, May 7,2018. This will be paid from the Water and Sewer Fund Repair and Maintenance line item. Councilmember Andrew Lemmon made the motion to proceed with the project with Councilmember Keith Anderson seconding the motion. Motion passed with all voting in favor. 5-0
